Sri Ravi Capoor, IAS, Additional Chief Secretary to the Govt. of Assam, Industries & Commerce Department & Chairman, State Level Committee presided over the meeting and welcomed all the members & officials present in the meeting and asked the Member Secretary to place the agenda before the committee for discussion & scrutiny.

Sri Bipul Das, Addl. Director of Industries & Commerce (DICC) & Member Secretary, State Level Committee welcomed the members and explained the purpose of the meeting and requested the members to deliberate on the Agenda placed before the committee.

Agenda 1: Confirmation of the Minutes of the last 37th SLC meeting held on 31.10.2015.

The Minutes of the 37th State Level Committee meeting held on 31.10.2015 were circulated among the members. As there was no observation or comments from any members, the Committee confirmed the Minutes.

Agenda 2: Discussion & approval of claims of 30% CCIS (Below Rs. 1.5 Crore)

The Member Secretary placed a total of 138 cases: 1 No. of High Court Case, 10 Nos. of deferred cases, 119 Nos. of fresh case, 4 Nos. of Electrical & 4 Nos. of any other matter cases.

The Member Secretary informed the committee that:

All the claims were scrutinized as per policy guidelines issued by DIPP, Government of India from time to time. He further informed about the procedures adopted for scrutinizing the claims before placing in the Committee. All the claims placed before the Committee had already been scrutinized at various levels. Physical verification was initially done by the office of the GM, DICC. In addition the office of the Commissioner, Industries & Commerce, Assam also carried out verification of the new/existing units under consideration. Senior Finance & Accounts Officer and Audit Cell of the office of the Commissioner, Industries & Commerce, Assam also verified the claims and admissibility of documents submitted by the claimants in the light of guidelines issued by Government of India till date. The Committee was also informed that the claim put up through agenda note by the office of the Commissioner, Industries & Commerce, Assam were found to be eligible, admissible and in accordance with the revised guidelines.




After threadbare discussion the Committee examined 81 nos. of CCIS claims out of 138 nos placed. Out 81 nos. of cases: - 64 nos. of cases were approved, 14 nos. of cases deferred and 3 nos. of cases rejected. The decision of SLC case wise is placed at **Annexure- A,B & C**

The meeting ended with a vote of thanks from the Chair.

Reason for deferment: The SLC deferred the case as it was seen that the forest department permission shows capital investment of ₹ 19.00 lakhs only whereas the present additional capital investment shown is ₹ 161.00 lakhs. Moreover there was no mention of expansion in the forest Department permit. Hence SLC directed that clarification should be obtained from forest Deptt.
