Agenda No- 1: Confirmation of the minutes of 16th SLC meeting held on 12.06.2018

As no comments were received from any members, the minutes of the 16th SLC was confirmed in the meeting.

Agenda item No- 2: Approval of claims of NEIP-97 under Central Comprehensive Insurance Scheme, 97.

Member Secretary explained the procedure adopted for scrutinizing the claims before placing in the Committee meeting. All the claims placed before the Committee had already been scrutinized by officers of Industries & Commerce, Assam as per guideline of DIPP, Govt. of India. Further Sr. Finance & Account Officer and his audit team of the Commissioner of Industries & Commerce, Assam has also vetted admissibility of the amount in the light of guidelines issued by DIPP, Govt. of India.

M/s. PDP Steel Ltd. and **M/s. Kamakhya Plastic Pvt. Ltd.** had filled Writ Petitions before the Hon'ble Guwahati High Court for consideration of Central Comprehensive Insurance Claims under NEIP' 97 vide No.- WP(C) 56/2018 & WP (C) 2004/2018 respectively. Accordingly the Hon'ble Guwahati High Court disposed off the Writ Petitions by order dtd.- 08-01-18 & 04-04-18 respectively with a direction to consider the claims for reimbursement of Insurance Premium as made by the Petitioner Companies in accordance with the scheme.

Thereafter as per decision of last meeting, 9 (Nine) Nos. claims of **M/s. PDP Steel Ltd.** and 4 (Four) Nos. claim of **M/s. Kamakhya Plastic Pvt. Ltd.** were placed for consideration of the committee. After threadbare discussion the Committee approved all 13 (Thirteen) Nos. of claims.
