

MINUTES OF THE 24<sup>th</sup> STATE LEVEL COMMITTEE MEETING FOR CENTRAL COMPREHENSIVE INSURANCE SCHEME (CCIS) UNDER NEIIPP-2007 HELD ON 06.04.2019 AT 11.00 AM IN THE CONFERENCE HALL OF THE ADDL. CHIEF SECRETARY TO THE GOVT OF ASSAM, INDUSTRIES & COMMERCE DEPARTMENT, ASSAM, ASSAM SECRETARIATE, DISPUR, GUWAHATI-6

At the outset Sri Biswajeet Das, Addl. Director, (NAZ) explained the purpose of the meeting and placed the agenda for discussion.

**Agenda No- 1 : Confirmation of the minutes of 23<sup>rd</sup> SLC meeting held on 11.02.2019**

The Minutes of the 23<sup>rd</sup> SLC meeting had been circulated to the members in the meeting and as no comments has received from the members, the Committee confirmed the minutes of the 23<sup>rd</sup> SLC meeting.

**Agenda No- 2 : Approval of claims of NEIIPP-2007 under Comprehensive Insurance Scheme, 2007.**

Sri Biswajeet Das, Addl. Director, (NAZ) explained the procedure adopted for scrutinizing the claims before placing in the Committee meeting. All the claims placed before the Committee had already been scrutinized by officers of Industries & Commerce, Assam as per guideline of DIPP, Govt. of India. Further Sr. Finance & Account Officer and his audit team of the Commissioner of Industries & Commerce, Assam has also vetted admissibility of the amount in the light of guidelines issued by DIPP, Govt. of India.

There after 18 (eighteen) nos. of claims were placed for consideration of the committee under NEIIPP'2007 policy and as resolved in 23<sup>rd</sup> SLC dt.06-03-19 10 (ten) nos. of claim were placed under NEIP'1997 policy. During the course of discussion, Chairman of the Committee raised question on authority of the SLC to consider the claims under CCI scheme of NEIP'1997 as (i) the policy has already ceased to operate w.e.f.31.03.2007 , (ii) DIPP, communication vide letter no 10(3)2007-DBA-II/NER dtd.15.02.2008 regarding processing of claim under Comprehensive Insurance Subsidy Scheme and (iii) Govt. Notification No.CI.250/20 dtd.11.02.2009 constituting SLC under NEIIPP'2007 has not mentioned anything about processing of Central Comprehensive Insurance Subsidy Claims of NEIP'1997 by the same committee. Form the department's side, it was clarified that the beneficiary group of both the policies of Govt. are different and it is clearly mentioned in the aforesaid notification that industrial unit which have commenced commercial production on or before 31.03.2007 will continue to get benefit/incentives under NEIP-1997.It was further informed that the 1<sup>st</sup> SLC held on 07.08.2009 for CCIS discussed on the DIPP's letter dtd.15.02.2008 and opined that the claims pertaining to the period from 01.04.2007 be brought under consideration of SLC and for the claims up to 31.03.2007 the existing policy procedure be followed for disbursement and accordingly proposal under NEIP'1997 were approved by SLC up to the 5<sup>th</sup> SLC dtd.01.02.2011.

However 6<sup>th</sup> SLC dtd.14.09.2011 vide agenda item no.2 decided that department should take clarification on the matter through DIPP through State Government. DIPP vide letter no 10(3)/2007-DBAII/NER dtd.23.07.2013 replied to the same, however not mentioned anything about that committee which will consider the Insurance Subsidy claim under NEIP'97.

The committee after detail discussion decided to consider claims under NEIIPP'2007 only in the current meeting and <sup>for</sup> ~~offer~~ balance CIS claims under NEIP'1997 till proper clarification from DIPP is obtained. *Refer*
