Sri R.K. Bhattacharyya, ADI (FP) and Member Secretary of the State Level Committee (SLC) welcomed all the members and officials present in the meeting and placed the Agenda items before the Committee for discussion, scrutiny and decision.

• **AGENDA No. -1:**

Confirmation of the Minutes of 44th Meeting for 3% CISWC under NEIIPP' 07 held on 05-04-2023 :

The Member Secretary informed the Committee that the claims mentioned in the Statement Sheet under Note Below as Sl. No. 3 & 4 under Column 3 (*Claims not admissible due to non submission of Bank Certificate Prior to Expansion*) falls under NEIIPP' 2007 instead of NEIP' 97. However, claims related to Manipur Tea Estate (a unit of M/s Manipur Tea Company Pvt. Ltd.) Manipurbagan, Hailakandi for the period 2009-10, 2010-11 and 2011-12 has already been placed in the SLC (Statement Sl. No. 19, 20 & 21). As no other comments were received from any Member, the minutes of 44th SLC for 3% CISWC held on 05-04-2023 under NEIIPP' 07 along with for the above mentioned changes was confirmed in the Meeting.

• **AGENDA No. -2 :**

Approval of New claims of 3% Interest Subsidy on Working Capital (CISWC) under NEIIPP' 07:

The Member Secretary placed 44 (Forty Four) Nos. of claims of 3% CISWC under NEIIPP'07.

Regarding the claims submitted by M/s Varun Beverages, Unit-II for the period 2013-14, 2015-16, 2016-17, 2017-18 and 2019-20 (Statement Sl. No. 38-42), the Member Secretary informed the Committee that although these claims were received in the Commissionerate on 26-07-2022 but the Online Submission for all the above claims were within the permissible time limit. However, as informed by the General Manager, DI&CC, Kamrup, the delay for submission of the claims were due to misplacement of the proposals during the bifurcation of DI&CC Office from Kamrup to Rural and Metro. In this regard, the Chairman took a serious note and directed the Member Secretary to issue a caution letter to General Manager of all districts, not to keep the proposals pending for a long duration and ensure follow-up actions for submission of claims on time.



After going through the statements of claims and deliberation by the SLC, the committee approved all 44 (Forty Four) Nos. of claims of 3% Interest Subsidy on Working Capital (CISWC) under NEIIPP, 07 as appended at ANNEXURE-I.
