Decision of pending Claims related to Court Case for Existing Unit which had undergone Substantial Expansion under NEIIPP' 07:

Joint Director (SP) has placed 13 (Thirteen) Nos. of claims of 3% CISWC under NEIIPP' 2007 before the committee. The Chairman stated that DPIIT vide notification dated 18.06.2014 has decided that the quantum of interest subsidy admissible in case of 'existing industrial units' which had undergone substantial expansion under NEIP' 1997/ NEIIPP' 2007 will be 3% of the increased in working capital loan actually drawn after undergoing substantial expansion over and above the average of the working capital loan availed by the industrial unit during two financial years just preceding the date of commencement of commercial operation after undergoing substantial expansion.

After going through the statements of claims and deliberation by the SLC, the committee approved 13 (Thirteen) Nos. of claims of which had undergone substantial expansion under NEIIPP' 2007 as appended at **ANNEXURE-II**.

Joint Director (SP), had placed 63 nos of claims received from the General Manager, DI&CC, Sonitpur in respect of M/s McLeod Russel India Ltd. for discussion before the SLC. After threadbare discussion it was found that the Tea Estates under McLeod Russel India Ltd. could not submit critical mandatory documents for processing the claims. Therefore, the SLC
