Sri Ravi Capoor, IAS, Additional Chief Secretary to the Govt. of Assam, Industries & Commerce Department & Chairman, State Level Committee presided over the meeting and welcomed all the members & officials present in the meeting and asked the Member Secretary to place the agenda before the committee for discussion & scrutiny.

Sri Biswajeet Das, Addl. Director of Industries & Commerce (UAZ) & Member Secretary, State Level Committee welcomed the members and explained the purpose of the meeting and requested the members to deliberate on the Agenda placed before the committee.

**Agenda 1: Confirmation of the Minutes of the last SLC** The Minutes of the 48<sup>th</sup> State Level Committee meeting held on 09.05.2018 were circulated among the members. As there was no observation or comments from any members, the Committee confirmed the Minutes.

**Agenda 2: Discussion & approval of claims of 30% CCIS (Below ₹1.5 Crore)**

The Member Secretary placed a total of **21 nos. of cases, out of which 02 Nos. of deferred cases and 19 Nos. of fresh cases.**

The Member Secretary informed the committee that:

All the claims were scrutinized as per policy guidelines issued by DIPP, Government of India from time to time. He further informed about the procedures adopted for scrutinizing the claims before placing in the Committee. All the claims placed before the Committee had already been scrutinized at various levels. Physical verification was initially done by the office of the GM, DIC, Senior Finance & Accounts Officer and Audit Cell of the office of the Commissioner, Industries & Commerce, Assam also verified the claims and admissibility of documents submitted by the claimants in the light of guidelines issued by Government of India till date. The Committee was also informed that the claim put up through agenda note by the office of the Commissioner, Industries & Commerce, Assam were found to be eligible, admissible and in accordance with the revised guidelines.

The Member Secretary further informed that all the financing banks were also invited to the SLC to appraise the status of their financing units.

After threadbare discussion and obtaining the views of the officials of the Banks / Financial Institutions of the claims financed by them, the Committee examined all **21 nos. of Central Capital Investment Subsidy** claims placed before the SLC and approved **21 nos. of cases.**

**Agenda 3: Any other matters.**

(a). *Correction of amount in the 46<sup>th</sup> SLC minute of M/S Saikia Tea Industries (Sl. No.-43) Garehagi, Panibharal, Biswanath Charali :*

The claim was placed in the 46<sup>th</sup> SLC held on 21.12.2017 and approved ₹ 24,58,321.00 (Rupees Twenty Four Lakhs Fifty Eight Thousand Three Hundred Twenty One) only as 30% CCIS against eligible investment of ₹81,94,402.00 (Rupees Eighty One Lakhs Ninety Four Thousand Four Hundred and Two). But in the minutes at **Sl.43 of Annexure-B** it was wrongly printed approved amount as ₹24,94,402.00 as 30% CCIS



against the eligible investment of ₹ 24,58,321.00. The Committee approved for correction of the minutes and to read as “**₹24,58,321.00 (Rupees Twenty Four Lakhs Fifty Eight Thousand Three Hundred Twenty One) only as 30% CCIS against eligible investment of ₹81,94,402.00(Rupees Eighty One Lakhs Ninety Four Thousand Four Hundred and Two)**”.

(b). *Discussion on Court case verdict:*

- i) WP(C) 3686/2012:M/S Ever Assam Tea Pvt. Ltd.
- ii) WP(C) 3883/2012:M/S Vision Ispat Pvt. Ltd.
- iii) WP(C) 4471/2012:M/S Iswar Food Products Pvt. Ltd.
- iv) WP(C) 6755/2010:M/S Jagunbari Tea Company

The Hon'ble High Court vide verdict on above mention cases issued order dated 27.02.2018 and directed to convey State Level Committee meeting within 6(six) weeks from the date of received of the certified copy of the order to take a fresh decision in respect of the application made by the petitioners herein for their claim of subsidy in accordance with the respective schemes by keeping in mind the observation made herein.


The Commissionerate already wrote to the Secretary to the Govt. of Assam, Industries & Commerce department vide letter dated 21.03.2018 to file a Writ Appeal against the judgment passed by the Hon'ble High Court. The Commissionerate also vide letter dated 24.04.2018 requested Standing Council to give legal opinion on next course of action. Reply to both the above stated letters are still awaited.


The Committee after detail deliberation resolved to seek **opinion of Department of Industrial Policy and Promotion (DIPP) on the matter and directed Commissionerate to take action accordingly.**

Next State Level Committee meeting will be held on 10<sup>th</sup> July, 2018 at 10 am.

The decision of State Level Committee case wise is placed at **Annexure-A & B**
