01.PART-I (TECHNICAL BID)

The Technical bid must be accompanied with the following documents, each page of which must be signed by the bidder with stamp affixed.

- 2.Earnest Money Deposits of Rs.5000/ in the form of Fixed deposit in favour of Senior Quality Control Officer, Guwahati - 21 payable at Guwahati drawn in any branch of nationalized bank or any other scheduled commercial bank..The validity of the EMD should be one year.
- 3.PAN and GST registration certificate.
- 4.Undertaking of **after sales service** and contasct details of the same
- 5.Technical specification of CCTV Surveillance system along with Technical literature/leaflet shall be submitted.
- 6.Income Tax Return acknowledgement letter for last two financial years

1. Rate (Both in figure and words) & amount against each machineries/equipment is to be filled up in bill of Quantities..
2. Price shall be inclusive of all Taxes, Duties, Packing & forwarding, Freight, Installation & commissioning, Trial Run, cost of cables & labour charge for laying, insurance, for installation and any other statutory levy as applicable at the laboratory situated at Industrial Estate, Bamunimaidan, Guwahati-21.

GENERAL TERMS AND CONDITIONS OF TENDER.

1. The Rate quoted should be indicated the detailed break up like the basic price, GST, Freight etc
2. Non conformity of Technical specification will lead to out-right rejection to the offer.
3. Manufacturer/Authorised Dealer shall be responsible for all services relating to Execution/commissioning, trial-runs etc. during Warranty period.
4. The bidder/vendor should visit the site location to assess the exact requirement of the work.
5. The bidder/vendor should be capable for annual maintenance of the Machinery/Equipment supplied after expiry of warranty period & shall be liable for annual maintenance, if and when offered to him at mutually agreeable rate.
6. Tender, addressed to the Senior Quality Control officer, Industries & Commerce department, Govt. of Assam, Industrial Estate, Bamunimaidan, Guwahati-21 can be submitted either in person or through Registered post/ speed post/ courier. 9. Manufacturer/ Authorized Dealer/ Supplier shall be responsible for all services relating to Machineries/Equipment supplied during warranty period.
10. Machinery / Equipment with ISI mark shall be given preferences.
11. Non submission of documents along with the tender as laid down may entail rejection of the tender.
12. The Procurement and Tender Selection Committee reserves the right to accept or reject any or all the tenders without assigning any reason thereof.

14. The Tenderer may submit quotation for all the Machinery / Equipment or a part of the list or any single Machinery / equipment.
15. The rate quoted shall be firm & fixed for the entire contract period.
16. The tendered rate against each machinery / equipment, in the price bid should be indicated both in figures & words. In case of any clerical error between the rate indicated in figures & words, the lower rate will prevail.
17. Submission of tender by the Tenderer implies that he has read the instruction in the tender documents, the general condition of contract & has made himself aware of the scope & the specifications of the work to be executed & accepted all terms & conditions.
18. The goods should be insured against theft, loss or breakage during transit.
19. Pre-Installation requisites (Electrical/ floor/ space/ air condition etc.) if any, should invariably be mentioned clearly. Installation/ training of the manpower will be the full responsibility of the supplier.

Final payment will be made after satisfactory Installation, Commissioning, demonstration & training of machinery/equipment.

COMPLETION PERIOD OF WORK: Within 31st January, 2019.

WARRANTY PERIOD : Minimum 3 (three) years warranty should be offered against each machinery/ equipment by the bidder from the date of commissioning of machinery/ equipment.

VALIDITY OF OFFER : The offer shall remain valid for a period of 1(one) year from the date of submission of offer.

Earnest money so paid will be released or returned as the case may be to the unsuccessful tenderer after the award to work is finalized. No. interest will be payable on EMD submitted.

For successful bidder who has submitted 2% earnest money, 8% of bill amount will be deducted & retained as security deposit along with the earnest money up to warranty period or otherwise equivalent amount of bank guarantee will have to be submitted & the validity of the bank guarantee will be at least up to warranty period.

For successful bidder who are exempted from depositing 2% earnest money under the provision of Govt. act/ circular etc., 10% of bill amount will be deducted & retained as security deposit or otherwise equivalent amount of bank guarantee will have to be submitted & the validity of the bank guarantee will be at least up to warranty period.

Awarding the supply order to the successful bidder is subject to the availability of fund. The undersigned will not be responsible for advance floating of tender. The tender submitted by telex/telegram/fax/email etc. shall not be considered. Conditional tender shall not be accepted. Canvassing in any form will entail disqualification / rejection of the tender offer.
