

MINUTES OF THE 37th & 17th MEETING OF THE STATE LEVEL COMMITTEE FOR 3% INTEREST SUBSIDY ON WORKING CAPITAL (CISWC) UNDER NEIP,97 HELD ON 9th MAY'2017 IN THE CONFERENCE HALL OF ADDITIONAL CHIEF SECRETARY, GOVT. Shri Ravi Capoor, IAS, Additional Chief Secretary to the Govt. of Assam, Industries & Commerce Department & Chairman of the State Level Committee (SLC) welcomed all the members and officials present in the meeting and asked the Member Secretary to place the Agenda items before the Committee for discussion and scrutiny.

AGENDA NO.1

Confirmation of the Minutes of 16th SLC Meeting held on 13.10.2015.

No comments were received from any Members. The minutes of 16th SLC was confirmed in the Meeting.

Circulars pertaining to the 3% interest subsidy on Working Capital (CISWC) under NEIP'97 & NEIPP' 07 were explained to the Members Present.

AGENDA NO.2

Follow up action of 36th & 16th SLC Meeting held on 13.10.2015 under NEIP'97 & NEIPP'2007-

A total of 63 Nos. of claims were deferred by the 16th SLC meeting held on 13.10.2015 to ascertain the Status of the Units. Accordingly the deferred claims were placed by the Member Secretary before the 17th SLC meeting along with Status report. As decided by the SLC a total of 6 Nos. of claims were approved amounting to ₹94,93,451.00 as 3% Interest Subsidy on Working Capital (CISWC) by the SLC, 22 Nos. of claims were decided to be re-examined & 6 Nos. of claims were rejected due to non-functioning of the unit as appended in Annexure-II.

There was a confusion in the name & style of M/s. **Amba Banijya (P) Ltd.**, & its subsidiary unit **M/s. Amba Industries Unit-II, Airport Road, Chaboti, Vill.-Choukham, Mouza- Nakari, Dist.- North Lakhimpur** as raised by the Additional Director (FP) & whether any Industrial Incentive is availed by the unit, if so than the Incentive was approved and paid in favour of **M/s. Amba Banijya (P) Ltd.**, or its subsidiary unit **M/s. Amba Industries Unit-II.** hence the SLC deferred the case & decided that the Commissioner of Industries & Commerce, Assam will examine the matter raised & take the decision accordingly.

AGENDA NO.3:

Approval of claims under 3% Interest Subsidy on working Capital (CISWC) under NEIP'97-

Accordingly the Member Secretary placed a total of 18 Nos. of claims before the SLC. After threadbare discussion 16 Nos. of the claims were approved amounting to ₹91,58,121.00 as 3% Interest Subsidy on Working Capital (CISWC) & 2 Nos. of the claims is decided to re-examine as appended in Annexure-III.

AGENDA NO.4:

Approval of Claims under 3% Interest Subsidy on Working Capital (CISWC) under NEIIPP'07-

Accordingly the Member Secretary placed a total of 286 Nos. of claims before the SLC. After threadbare discussion 227 Nos. of the claims were approved amounting to ₹21,58,28,904.00 as 3% Interest Subsidy on Working Capital (CISWC) by the SLC, 8 Nos. of the claims were deferred, 33 Nos. of claims were rejected, 3 Nos. of claims were decided to re-examine the status, 17 Nos. of claims of Expansion units were decided to ascertain the Investment & Production as per the NEIIPP Guidelines, 2 Nos. of claims were decided to recheck & 2 Nos. of claims were decided to check the status & present before the next SLC as appended in **Annexure-III.**

Further an additional list of 19 claims was placed before the SLC. After threadbare discussion 14 nos. of claims were approved amounting to ₹5,68,46,712.00 as 3% Interest Subsidy on Working Capital (CISWC) by the SLC, 4 Nos. of claims of Expansion units were decided to ascertain the Investment & Production as per the NEIIPP Guidelines & 1 No. of claim is rejected by the SLC as appended in **Annexure-VI.**

AGENDA NO.5:

Approval of Expansion Claims under 3% Interest Subsidy on Working Capital (CISWC) under NEIIPP'07-

In case of the Expansion units, the SLC decided to re-examine the investment in Plant & Machinery and production comparing at least 2 (two) years of production, turnover etc data submitted to Excise, Tea Board, IT, Tax etc Department to ascertain whether the mandatory criteria of 25% enhancement of production etc have been meet as per NEIIPP guidelines.
