The terms of reference of the Internal complaints Committee shall be as follows:

1. To receive complaints of sexual harassment at workplace under Sec 9.

2. To attempt conciliation at the request of aggrieved person in respect of the complaints under Sec 10.

3. To make enquiry into complaints if necessary and take action under Sec 11 to Sec 18 of

As empowered by the Act u/s 11(3) the Internal complaints Committee shall have the same powers as are vested in a civil court under the code of civil procedure, 1908 when trying a suit in respect of the following matters, namely:-

a) Summoning and enforcing the attendance of any person examining him on oath

b) Requiring the discovery and production of documents and

Any other matter which may be prescribed.

The enquiry shall be completed within a period of 90 (ninety) days as per Sec 11(4) (1) of the Act.
