**III. JOB DESCRIPTION AND RESPONSIBILITIES:**

The Managing Director is the Chief Executive of the Company and is accountable to its Board of Directors and Government of Assam. He/She is responsible for the efficient functioning of the Company for achieving its corporate objectives/goal and performance parameters. The Job requires a person of outstanding professional competence and proven managerial ability. He/She should have required ability and leadership qualities to direct a multidisciplinary and highly qualified team to achieve the objectives of the organization. He/She should have sharp business acumen with demonstrated sensitivity to the external business environment and the ability to spot opportunities and exploit them to the advantage of the company.

**IV. ELIGIBILITY:**

**A. AGE:**

Minimum age of the applicant should not less than 45 years and maximum age should not exceed 57 years as on 1<sup>st</sup> October, 2023.
