Member Secretary placed the Court matter of M/S PDP Steel Ltd. and M/S Kamakhya Plastic Pvt. Ltd along with Hon'ble High Court order's before the Committee. She informed the house that in the 6th SLC of NEIIPP-2007 dated 14-09-2011 directed to obtain a clarification regarding the authority of the SLC from DIPP through State Govt. to consider the claims under NEIP-1997 and accordingly State Govt.requested DIPP Govt. of India for necessary clarification vide letter no. CI.58/2007/63 DATED 12TH July;2012. However the clarification has not received till date.The Committee discussed the matter and decided to defer the mater in the next SLC with a direction to verify and examine the claims of petitioners since these claims are very old and need justification with supporting documents.The committee also suggested to obtain the clarification from DIPP immediately.

The next SLC is fixed on 10TH June'2018.
