1. Government of India has received a credit from International Development Association (IDA) in various currencies equivalent to USD 262.40 million towards the cost of APART and intends to apply part of the proceeds of this credit to eligible payments under the contract for which this invitation for quotation is issued.

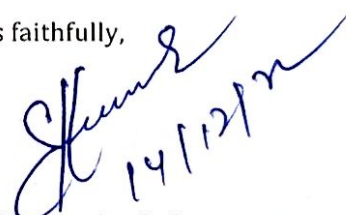
Government of Assam has been endeavoring to improve the online service delivery environment in the State by implementing the various recommendations under Business Reforms Action Plan (BRAP) 2022. The BRAP 2022 exercise is completely based on user feedback scores which depend on the perception of Service Users and their particular experience in accessing services. In order to build perception of users in accessing the services and also to increase ease of accessing information online which is also expected to impact their feedback in the upcoming evaluation to be carried out by DPIIT, the Single Window Agency, Government of Assam wishes to engage an agency to develop designs and install hoardings signages/ Standees & in Guwahati, Assam in the first phase.

CI&C now intends to engage an Agency for "Design, printing, supply and installation of hoardings/signages for Ease of Doing Business (EoDB) in Assam" and hence seek quotations from reputed Firms /Agencies/ Companies for the aforementioned service. The details are given below:

4. The sealed envelope should be superscribed as **"DESIGN, PRINTING, SUPPLY AND INSTALLATION OF HOARDINGS/SIGNAGES FOR EASE OF DOING BUSINESS (EoDB) IN ASSAM "**; Not to be opened before **21<sup>st</sup> Dec., 2022 at 11.30 AM.**

6. Quotations received shall be opened on the same day, i.e. **21<sup>st</sup> Dec., 2022 at 11.30 AM** in presence of the bidders or their representatives who choose to attend at the office of the undersigned. If the office happens to be closed on the date of opening of the Quotations as specified, the Quotations will be opened on the next working day at the same time. The CI&C shall not be held liable for any delay in the receipt of Quotations.
7. The Commissioner, CI&C reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract, without assigning any reason thereof and without thereby causing any liability to any of the bidder.

## Section I

### Instruction to Bidder

This RFQ documents is in connection with "DESIGN, PRINTING, SUPPLY AND INSTALLATION OF HOARDINGS/SIGNAGES FOR EASE OF DOING BUSINESS (EoDB) IN ASSAM" under APART.

#### A) PREPARATION AND SUBMISSION OF QUOTATION:

- i) Quotation shall be addressed to "The Commissioner, Commissioner of Industries and Commerce, APART, Udyog Bhawan, Bamunimaidam, Guwahati-21."
- ii) Quotations shall be submitted as per the format given at Annex- I along with other supporting documents as mentioned in the bid with a copy of the RFQ placed in a single sealed envelope, clearly marked as "DESIGN, PRINTING, SUPPLY AND INSTALLATION OF HOARDINGS/SIGNAGES FOR EASE OF DOING BUSINESS (EoDB) IN ASSAM"; Not to open before 21<sup>st</sup> Dec., 2022 at 11.30 AM." The name of the bidder, address and contact no. should be mentioned on the reverse of the sealed envelope.
- iii) All pages of the quotation shall be signed and stamped by the authorized person to indicate that the bidder has agreed to all terms and conditions of the quotation. Overwriting, alterations, if any, in the quotation should be signed by the authorized signatory.
- iv) Quotation not accompanied by specified documents, Self-declaration, signatures and signed copy of this RFQ may be rejected by the office as non-responsive and may not be evaluated.
- v) Any quotation received after the dead line for submission shall be rejected & returned to the bidder.

#### B) BID PRICE

- i) The contract shall be for quantity as specified in the Price quotation, corrections of the quoted rate, if any, shall be made by crossing out, initiating, dating and re-writing.
- ii) Rate should include the cost of design, printing, installation, Rental, Recce and dismantling.
- iii) 'Discount' or extra charges if any mentioned by the bidders shall not be considered unless these are specifically indicated in the price quotation.
- iv) All duties taxes and other levies payable by the supplier under the contract shall be included in the total price.
- v) GST shall be shown separately.
- vi) The rates quoted by the bidder as per Annexure - III shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- vii) The price shall be quoted in Indian Rupees only.

**C) EACH BIDDER SHALL SUBMIT ONLY ONE QUOTATION**

**D) VALIDITY OF QUOTATION**

Quotation shall remain valid for a period not less than 30 days after the deadline date specified for submission.

**E) THE QUOTATION SHALL COMPRISE THE FOLLOWING:**

- i) Letter of Quotation as per format given at annexure-1
- ii) Signed (each page) copy of RFQ document.
- iii) Copy of Credential certificates (Works completion certificates) issued by the Clients during last Two years.
- iv) Relevant experience in creating designs for any Govt. campaigns.
- v) Sample Designs (3 nos.)
- vi) Copy of Audited Financial Statements of last Three Years.
- vii) Copy of GST Registration certificate.
- viii) Copy of PAN Card.
- ix) Trade License copy.

**F. OPENING OF QUOTATION:**

The quotations shall be opened in the presence of bidders or their authorized representative who wish to be present at the time of opening of bids on due date.

**G. EVALUATION OF QUOTATION:**

The purchaser shall evaluate and compare the quotations determined to be substantially responsive, i.e. which,

- i) are properly signed and sealed;
- ii) Are supported with registration certificate, PAN Card etc.
- iii) Conform to the terms, conditions and specifications.
- iv) All documents as mentioned in 'Point No.E' above.

**H. AWARD OF CONTRACT:**

- i) The Commissioner, Commissioner of Industries and Commerce, Assam will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest responsive price.
- ii) Notwithstanding the above, The Commissioner, Commissioner of Industries and Commerce, Assam reserves the right to accept or reject any quotation and to cancel the bidding process and reject all quotations at any time prior to the award of the contract.
- iii) The bidder whose quotation is accepted will be notified of the award of the contract by The Commissioner, Commissioner of Industries and Commerce, Assam prior to the expiration of the quotation validity period.

**I. PAYMENTS:**

- i) Payment shall be made within 15 days from submission of bills with copy of photographs of the deliverables.
- ii) All payments shall be made by Account Transfer only.
- iii) All taxes (including GST, etc.) shall be dealt with as per the Govt. laws
- iv) No advance payment shall be made.

**J. SUB-LET:** The bidder shall not at any time assign, sub-let or make over the contract or the benefit thereof or any part thereof to any person or persons whatsoever.

**K. PENALTY:**

If the progress of assignment is found to be non-satisfactory or delayed at any point of time, Commissionerate of Industries & Commerce reserves the right to impose penalty. The total amount of penalty shall be determined by Commissionerate of Industries & Commerce giving adequate justifications subject to a maximum of 10% of the contract value.

**L. LAWS GOVERNING THE CONTRACT & JURISDICTION:** The contract shall be governed by the laws in force in India. In the event of any dispute, such dispute would be subject to the courts in Guwahati only.

- h) In case the locations are not available at the time of confirmation, suitable alternatives may have to be provided
- i) Recce, Design, Installation and uninstallation of the hoardings/signages as per specification and brief
