Dear Sir/Madam,

As you are aware, Govt. Of Assam in collaboration with DPIIT is conducting the Ease of Doing Business (EoDB) exercise by implementing the reform points given under BRAP 2022, the reform points have been shared to the department.

In this regard, the deadline for uploading of evidence of the implemented reform points as provided by DPIIT is 31st Oct 2022. Out of the total 352 reform points given by DPIIT, 109 reform points have been retained from previous year exercise and thus no further evidence is required to be furnished by the departments.
