No.MI.169/2019/48: In pursuance of the Para 1.1(i) of Operational Guidelines of NEIDS, 2017; a **Field Visit Team** for the claims of Central Capital Investment Incentive for Access to Credit (CCIIAC) where value of investment in eligible Plant & Machinery is from Rs.5.00 crores to Rs.20.00 crores is hereby constituted with the following members with immediate effect and until further orders.

1. Representative of Industries & Commerce Department.
2. Representative of Commissioner, Industries & Commerce, Assam
3. Representative of NEDFi
4. Representative from Financial Institution concerned.

In case of investment in eligible Plant & Machinery is above Rs.20.00 crores, Representative of DPIIT, Government of India will also be a member of the Field Visit Team.

Terms of Reference

- (i) **Field Visit Team** shall verify the physical availability of the Plant and Machinery in respect of which claim has been made by the industrial unit.
- (ii) **Field Visit Team** shall ascertain whether the components/items of these plant and machinery in respect of which subsidy claimed by the industrial unit is as per the provisions of the scheme and subsequent clarifications issued from time to time.
- (iii) **Field Visit Team** shall invariably consider the Appraisal Report of the Financial Institution (s) of the industrial unit along with other relevant documents while assessing the quantum of the value of plant and machinery.
- (iv) **Field Visit Team** shall suitably explain the deviations (if any) in the value of plant and machinery considered eligible for subsidy from the Appraisal Report. The deviation report shall be submitted as per the format given at Annexure.
- (v) **Field Visit Team** shall submit field visit report within 5 (five) working days from the date of completion of field visit of the unit.


