Approval of claims of 3% Interest Subsidy on Working Capital (CISWC) under NEIP, 97:

The Member Secretary placed 7 Nos. of claim proposals of M/s. Satyanarayan Tea Estate, (A unit of Satynarayan Tea Pvt. Ltd.), Naharkatia, Dibrugarh, an existing unit which has gone into substantial expansion under NEIP, 1997 and commenced commercial production after expansion on 12-03-2004 before the Committee. The Committee was appraised that 3% CISWC proposals of the unit for the period as detailed below were submitted to DI&CC, Dibrugarh prior to the notification issued by DPIIT, Govt. of India Vide No.- 9(1)2011-DBA-11/NER dtd.-18-06-2014.

Due to shortfall of documents, proposals were returned to DI&CC, Dibrugarh and were resubmitted by GM DI&CC, Dibrugarh on 15-03-2019. Financial components were verified with the Bank Statements by Audit Team of the Commissionerate while Sr. FAO observed that bank certificate for the period 2 years prior to expansion in pursuance to the DPIIT, Govt. of India Notification Vide No.-9(1)2011-DBA-11/NER dtd.- 18-06-2014 need to be submitted by the unit. Since, quoted notification is after the date of commencement of commercial production after expansion as well as date of submission, matter was taken up with DPIIT & subsequent reminder also sent. However, response from DPIIT. Govt. of India is yet to receive.

Further, the Committee was appraised that 3% CISWC claim of the unit after expansion for the period 25-03-04 to 31-03-05 amounting to ₹8,23,860.00 was approved by the SLC held on 31-08-2005 and disbursed by NEDFi also.

After threadbare discussion the Committee deferred the claims and asked Commissioner of Industries & Commerce, Assam to take up the matter again with DPIIT, Govt. of India.
