**Confirmation of the Minutes of 38<sup>th</sup> Meeting for 3% CISWC under NEIIPP' 07 held on 17-07-2021 :**

As no comments were received from any Member, the minutes of 38<sup>th</sup> SLC for 3% CISWC under NEIIPP' 07 were confirmed in the Meeting.

- **AGENDA No. -2** :

**Approval of New claims of 3% Interest Subsidy on Working Capital (CISWC) under NEIIPP' 07:**

The Member Secretary placed 81 (Eighty One) Nos. of claims of 3% CISWC under NEIIPP'07. After going through the statements on claims and deliberation by the SLC, committee approved all 81 (Eighty One) Nos. of claims of 3% Interest Subsidy on Working Capital (CISWC) as appended at **Annexure-I**. All units have Bank Certificates in original and are functioning smoothly as per report of the General Managers, District Industries & Commerce Centre.

**Decision of Deferred claim under NEIIPP' 07:**

3% CISWC claim of M/s Hayat Hospital Pvt. Ltd., Odalbakra, Guwahati, Kamrup (M) under NEIIPP, 2007 for the period 01-04-18 to 31-03-19 amounting to Rs.8,25,032.00 was placed in the 37<sup>th</sup> SLC meeting held on 11-12-2020 and the SLC deferred the claim with direction to re-verify the claim by a Senior Official from the Commissionerate regarding diversion in utilization of working capital, if any. Accordingly, Shri Tarun Kataki, Joint Director (Extn.) verified the claim and found no diversion in utilization of working capital. The unit is functioning as per re-verification and the Bank Certificate in original is also with the claim. The Committee approved the claim and the admissible 3% CISWC comes to Rs.8,25,032.00 as appended at **Annexure-II**.
