**Any other matter with the permission from the Chair:**


The Committee was apprised that the Guidelines for Interest Subsidy on Term Loan is yet to be issued by DPIIT, though the same was taken up with DPIIT several times. The Committee directed the Member Secretary to take up the matter with DPIIT, Govt. of India once again.

The Committee directed that in case of claims where Original copy of Bank certificate is not provided by the DI&CC, in such cases GM, DI&CC shall certify the Xerox copy is verified with the original.


The Committee also decided that in case of disbursement to units where Bank Details is not available with NEDFi, in such cases NEDFi shall collect the Bank Details directly from the unit and make the disbursement as they are the nodal disbursement agency.

The Chairman also directed that all claims received by DI&CC should be verified and forwarded by General Manager, DI&CC, invariably to the Commissioner of Industries & Commerce, Assam within 15 (Fifteen) days of receipt of claims. It is further decided that Member Secretary shall get all the claims placed before the SLC within one month from the date of receipt from DI&CC.
