Approval of claims of 3% Interest Subsidy on working Capital under NEIIPP' 07:

The Member Secretary placed 92 No. of claim proposals under NEIIPP'07. After deliberation by the SLC, the Committee approved 73 No. of claim proposals and deferred 19 No. of claim proposals of 3% Interest Subsidy on Working Capital (CISWC) respectively. ### • AGENDA No. -3:

Issue of Corrigendum in Minutes of 32<sup>nd</sup> SLC Held on 15-05-2019

The Claim proposal of **Saradamoni Food Products**, *Vill.- Malua, Karimganj* for the period 01-04-2017 to 31-03-2018 was shown as approved by the 32<sup>nd</sup> SLC held on 15-05-2019 due to typographical error. The unit has commenced its commercial production wef 18-08-2016 & registered under the policy on 01-06-2016. As per DPIIT (the then DIPP), Govt. of India Office Memorandum No.- 10(3)/2007-DBA-II/NER dtd.- 15-12-2016, Interest Subsidy for New Industrial units/ Existing Industrial units going for substantial expansion (which registered and commenced

Production on or after 01-12-2014 & on or before 31-03-2017) will be available only on Term Loans. Hence, the unit comes under the purview of aforesaid circular of DPIIT, Govt. of India.

After threadbare discussion the Committee directed to make correction in the minutes of 32<sup>nd</sup> SLC held on 15-05-2019. The decision of 32<sup>nd</sup> SLC against the claim proposal of **Saradamoni Food Products**, *Vill.- Malua*, *Karimganj* at Sl.- 22 of **Annexure-II** may be now read as "The SLC rejected the claim proposal as the claim of the unit falls under Interest subsidy on Term Loan".

The Committee was also appraised that, the Guidelines for Interest Subsidy on Term Loan is yet to be issued by DPIIT. The Committee directed to take up the matter with DPIIT, Govt. of India once again.
