Sri Biswajeet Das, Addl. Director, (NAZ) explained the procedure adopted for scrutinizing the claims before placing in the Committee meeting. All the claims placed before the Committee had already been scrutinized by officers of Industries & Commerce, Assam as per guideline of DIPP, Govt. of India. Further Sr. Finance & Account Officer and his audit team of the Commissioner of Industries & Commerce, Assam has also vetted admissibility of the amount in the light of guidelines issued by DIPP, Govt. of India.

There after 4 (four) nos. of claims were placed for consideration of the committee. After threadbare discussion the Committee approved all 4(four) nos.

Member Secretary then informed the committee that about 60 nos. of Insurance Subsidy claims under 1997 policy are pending in this office which could not be placed before SLC due to the resolution adopt in 6<sup>th</sup> SLC dtd.14.09.2011 of SLC under NEIIPP'2007 and non receipt of further clarification thereof. The committee opined to take view of the Commissioner of Industries and Commerce, Assam for consideration etc. of the same.


