

1. Bid Price

- a. Bidder has to quote the price as per prescribed format in **Annexure-III**.
- b. The contract shall be for full quantity as described above. Corrections, if any in the bid, shall be made by crossing out, initialing, dating and re writing.
- c. All duties, taxes and other levies payable on components, and transportation & Installation at site shall be included in the total price.

- d. Quoted price should be including of GST.
 - e. The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
 - f. The Prices shall be quoted in Indian Rupees only.
2. **Each bidder shall submit only one quotation.** The Envelope should be superscribed with "quotation for Installation of 500 Mbps Corporate Internet Broadband Connection" at **the Commissioner of Industries & Commerce, Assam, Udyog Bhawan, Bamunimaidam, Guwahati-781021**".
3. **Validity of Quotation.**
Quotation shall remain valid for a period not less than 30 days after the deadline date specified for submission.
4. **Evaluation of Quotations**
The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which
- (a) Are properly signed; and
 - (b) Confirm to the terms and conditions, and specifications.
5. **Documents to be submitted**
- (a) Up-to-date Trade License
 - (b) DoT License.
 - (c) GST Registration Certificate
 - (d) PAN Card
 - (e) Self-attestation certificate certifying that the firm is operating as an Internet service provider located in Assam for at last 5 years or more with supporting documents.
 - (f) Satisfactory performance report from previous client for minimum last 3 years is to be submitted.
 - (g) Conform to the terms and conditions, and specifications.
 - (h) ISP/Bidder should have minimum average turnover of INR 50 Lakhs during last 3 financial years i.e. 2019-20, 2020-2021, 2021-2022 (Copies of audited financial statements should be submitted).

The RFQ and its Annexure along with all supporting documents of each page duly stamped and signed by the authorized signatory.

Failure to submit the above mentioned documents will be a cause to disqualify the quotation.

6. Award of contract

- 6.1 The Purchaser will award the contract to the service provider/s whose quotation has been determined to be substantially responsive and who has/have offered the lowest evaluated quotation price.
- 6.2 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract without specifying any reasons.
- 6.3 The service provider/s whose quotation is accepted will be notified of the award of contract by the CI&C prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order.
- 6.4 In case of a tie, the Authority may ask the bidders, who are tied to submit the revised quote with all the conditions of the RFQ remaining unchanged. The bidders who quote the lowest revised quote shall then be declared as the successful bidder.

6. Payment term:

- (a) Payment shall be made within 15 days after receiving the monthly bills/invoices and acceptance/approval of the same.
- (b) Monthly utilization service report in hard copy with Quality & Failure will be submitted at the end of each service month.

7. Duration of Contract

The service contract is 1 year from the date of installation. The contract may be renewed based on the satisfactory performance which will be decided by the Commissionerate of Industries & Commerce, Assam.

8. Termination

The Commissionerate of Industries & Commerce, Assam may terminate the contract with **1(one) month** prior notice, without assigning any reason thereof.

Technical Specification for Installation of 500 mbps corporate broadband connection

1. The scope of work includes supply, installation, configuration, provisioning, commissioning, management & monitoring of proposed Internet circuit.
2. Bidder must be a Class-A,B or C ISP / Unified license holder for DoT, Govt. of India.
3. The Bidder shall have an experience in providing Internet bandwidth on Fiber of at least 250 mbps to single large organization. **(Customer PO copy to be submitted)**.
4. The Bidder should have at least 3 Gig Capacity link.
5. Packet Losses: Less than 1% (Average over 1000 ping) at any given point of time to any part of globe.
6. The Bidder shall be responsible for undertaking all civil/electrical works related to the work.
7. Time of completion of the entire work will be **3 (three) days** from the date of signing of the agreement.
8. The Bidder should provide all operation, service and maintenance during the contract duration without charging any additional charges.
9. The Bidder has to ensure minimum 99.0% uptime per month for the connectivity.
10. During downtime the resolve time should not be more than 2 hours.
11. The Bidder should have Toll Free number for fault registering and should provide support on 365 x 24 x 7 basis.
12. In case of major hardware breakdown, the response time for attending the faults will be **3 hours (max)** after they are reported to the Internet Service Provider (ISP). The ISP will rectify the faults within **24 hours** failing which; ISP will arrange a temporary replacements.
13. During downtime the resolve time should not be more than 3 hours.
Downtime due to the following situations will not be considered for the purpose of penalty:
 - a) Link down due to power failure / or any situation which are beyond the control of service provider.
 - b) Due to schedule maintenance by the Service Provider, with prior approval.
14. The Internet Service Provider has to provide onsite support, as and when required by the Commissionerate of Industries & Commerce, Assam .
15. Bidder has to mention the escalation procedure and matrix for customer complaints
