No.CI.151/2018/146 : On the recommendation of the Assam Public Service Commission vide letter no.: 89PSC/PS-15/2017-2018 dated 17-02-2018, the Governor of Assam is pleased to appoint the following Assistant Managers/Superintendent of Industries/Assistant Industries Officers/Commercial Managers etc under the Industries & Commerce Department, Govt. of Assam, in the scale of pay of **Rs.30,000-Rs.1,10,000 (PB-4) with Grade Pay Rs.12,700** plus other allowances as admissible under the Rules and in the interest of public service posted against vacant posts as shown against their names.

The appointment is purely temporary and may be terminated at any time without notice assigning any reason thereof. His / Her service is liable to be transferred to anywhere in Assam including the Hill Areas / Autonomous Council Areas in Assam.

The appointees joining the State Government service on or after 01-02-2005 shall not be governed by the existing Assam Service (Pension) Rules, 1969 and orders issued there under from time to time. Their pension & other retirement benefit will be governed by New Pension Scheme, 2005.

He / She should join in his / her new place of posting within 15 (fifteen) days from the date of receipt of the notification.

No T.A. / D.A. is admissible either on joining in the post or in termination of appointment.

The inter-se seniority will be fixed later on or as per merit list recommended by the APSC.
