The Member Secretary placed the claim before the SLC for discussion and deliberation. The self financed Unit was appraised by City Bank , Hyderabad . The status of the unit was discussed in the meeting and the Committee was informed that the unit was running smoothly.

The Committee examined the claim and after threadbare discussion accepted the amount recommended by Commissioner of Industries & Commerce as eligible investment amounting to Rs 102566031.00 which is lower than the amount of Rs. 102634681.00 recommended by Field Visit Team. The difference was due to deduction of some ineligible payment identified during financial scrutiny by the Audit Team of office of the Commissioner of Industries & Commerce, Assam

The Committee approved Eligible Investment of Rs 102566031.00 (Rupees Ten Crore Twenty Five Lakh Sixty Six Thousand and Thirty One)only and Rs. **3,07,69,809.00 (Rupees Three Crore Seven Lakh Sixty Nine Thousand Eight Hundred Nine)** only as quantum of 30% CCIS.

The meeting ended with vote of thanks from the chair.
