Background

e-Governance is the application of information and communication technology (ICT) for delivering Government services, exchange of information communication transactions, integration of various stand-alone systems and services between Government-to-Citizen (G2C), Government-to-Business (G2B), Government-to-Government (G2G) as well as back office processes and interactions within the entire Government framework. A host of utility and e-commerce services are now being made available to all sections of citizen to their doorstep in online and mobile platform. The Government of India is embarking on e-Governance with new 'Digital India' programme for electronic delivery of services uniformly throughout the country and it is going to play a pivotal role in delivering information and services to the poor and underserved citizens living in the rural areas of the country.

Moreover, in view of demonetisation and current economic policy measures of the Government, cashless transactions through electronic channels like Debit and Credit Cards, Internet and mobile banking, Electronic Clearance System, NEFT, RTGS has gained a significant importance for general public. Government in collaboration with financial institutions has launched a host of new mobile based digital payment Apps for encouraging cashless transactions in Government to Citizen, Citizen to Government, Government to Business, Citizen to Citizen and Citizen to Purchase Outlets. Higher degree of cashless transactions may play an important role in curbing corruption and black money flow thus speed up economic growth of the country. However, rural citizen may have initial hesitation to adopt digital payment methods due to lack of technology, infrastructure, skill and awareness on advantages of such options. Under this scenario, it is the urgent need of the hour for awareness generation, skill enchantment of RD functionaries for mass use of digital payment methods for steady shifting towards cashless transactions in rural India.

Keeping in view the above parameters, the training programme on "e-Governance Services and Digital Financial Transactions" is proposed mainly for the functionaries of rural development and other line departments. This course shall provide a platform to discuss the various citizen centric e-Governance services as well as cashless transactions methods.

Objectives:

The main objectives of this training programme are:

- To familiarize with various e-Governance of services, public utility services
- To comprehend the various components of digital empowerment.
- To develop technical skills in digital fund transfer and Payment methods
- To Motivate on advantages of cashless transactions
- To understand the security measures in digital payment methods
