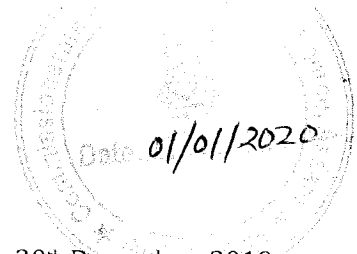

Terms of Reference

- (i) All claims pertaining to Central Capital Investment Incentive for Access to Credit (CCHAC), where investment in eligible Plant and Machinery is upto Rs.20.00 crores will be approved by the State Level Committee (SLC).
- (ii) All other claims pertaining to Interest Incentive, Insurance Incentive, and Transport Incentive where annual/quarterly claims is above Rs.20.00 lakh will be approved by the State Level Committee (SLC).
- (iii) The State Level Committee (SLC) shall go into details of each case to decide whether the unit qualifies for grant of incentive and also about the quantum of incentive.
