The total amount of penalty shall be determined by Commissionerate of Industries & Commerce giving adequate justifications subject to a maximum of 10% of the contract value.

M. LAWS GOVERNING THE CONTRACT & JURISDICTION: The contract shall be governed by the laws in force in India. In the event of any dispute, such dispute would be subject to the courts in Guwahati only.
